The appointment of these candidates shall be subject to the following conditions:-

- (I) Each appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from the Inspector General of police (CID), J&K, to whom a reference shall be made by the Principal, GMC Kathua, the candidate shall have

no right to claim his /her appointment and his/ her appointment as such, shall be deemed to have been cancelled ab-initio.

- (II) Verification/ genuineness of the qualification certificates and the reserved category certificates from the concerned issuing authorities.
- (III) The salary of the appointees shall not be drawn and disbursed to them unless the satisfactory report in respect of (I) and (II) above are received in their favour.
- (IV) The appointment of these candidates shall be governed by SRO-202 of 2015 dated 30.06.2015.
- (V) The appointees shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24.12.2009.
- (VI) The interim arrangement, if any, made against the above posts shall be deemed to have been terminated forthwith.
- (VII) The appointment in Divisional cadre is not transferable from one Division to another or from one Medical College to another.
- (VIII) The appointment of the selected candidates shall further be subject to outcome of writ petitioner(s), if any, pending on the subject in any court of competent jurisdiction.
- (IX) The inter-seniority of the above appointees, shall be as per the merit secured by them in the Selection process as indicated against each in the select list furnished by the J&K Services Selection Board.
