APPLICATIONS SHOULD BE ACCOMPANIED WITH ATTESTED COPIES OF THE FOLLOWING DOCUMENTS:

- MBBS certificate from 1st to final year MBBS
- Attempt certificate of 1st, 2nd, Pre-final and Final MBBS issued by concerned Universities.
- MBBS degree and MCI or State Medical Council registration certificate
- Internship completion certificate.
- Distinction/National scholarship/Honours/Medals/Academic Merit Certificate if any.
- House-job (Jr.) certificate issued by concerned Principal or Equivalent authority.
- Date of Birth Certificate.
- Permanent Resident Certificate/ Domicile Certificate

The selection of the candidates will be made as per the guidelines prescribed by the Government subject to amendment by the Govt. from time to time. Only those candidates who will have permanent registration certificate from the State Medical Council or MCI will be eligible for applying.
