Consequent upon the approval conveyed vide Health & Medical Education Department, J&K Jammu letter No. ME/NG/New/GMC/05/2019-PF Dated 08-02-2021 and release of recommendation by J&K Service Selection Board Vide No SSB/Secy/ Sel J/80/2020/324-326 Dated 14-01-2021, and in reference to cancellation of appointment of candidates vide this office order issued under endorsement no GMCR/2020/435-39 Dated 30-01-2020, the candidate next in merit list/ waiting list are hereby appointed for the post of "Nursing and Para Medical Staff/ Technical Assistant/ Technician" (Divisional Cadre Jammu), as per the details given below carrying the pay scale of PB-1 (5200-20200) with grade pay of Rs 2400 (Pre revised) now revised to Level 4 (25500-81100) (under Jammu and Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of tenure Rules, 2020, notified vide S.O 192 dated 17-06-2020 & S.O 193 dated 17-06-2020) with immediate effect in Govt Medical College Rajouri.

The appointment of these candidates shall be subject to the following conditions.

- (i) The appointee shall report to the Principal Govt. Medical College Rajouri within 21 days from the date of issue of this order along with all the original certificates, two photo copies of all educational and other concerned certificates i.e. Permanent Resident Certificate, Category Certificate No Objection/Loan Certificate from District Industrial Centre, District Employment Exchange, Character Certificate and Medical Certificate Signed by Chief Medical Officer.
- (ii) In case any appointee does not join within a period of 21 (Twenty one) days from the date of issuance of the appointment order shall forego their right to appointment which shall be deemed to have been cancelled ab-initio without serving any further notice.
- (iii) Each appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from the Inspector General of Police (CID), J&K, to whom a reference shall be made by the Principal, GMC Rajouri, the candidates shall have no right to claim his/her appointment and his/her appointment as such, shall be deemed to have been cancelled ab-initio.
- (iv) Verification/ genuineness of the qualification certificates and the reserved category certificates from the concerned issuing authorities.
- (v) The Salary of the appointees shall not be drawn and disbursed to them unless the satisfactory report in respect of (III) and (IV) above are received in their favour.
- (vi) The appointment of these candidates shall be governed by under Jammu and Kashmir Probationer (Condition of Service, Pay and Allowances) and Fixation of tenure Rules, 2020, notified vide S.O 192 dated 17-06-2020 & S.O 193 dated 17-06-2020.
- (vii) The appointees shall be governed by the "New Pension Schemes" as notified vide SRO-400 of 2009 dated 24-12-2019.
- (viii) The Interim arrangement, of any made against the above posts shall be deemed to have been terminated forthwith.
- (ix) The appointee in Divisional Cadre is non transferable from one Division to another or from one Govt. Medical College to another.
- (x) The inter-seniority of the above appointees shall be as per the merit secured by them in the Selection process as indicated against each in the select list furnished by the J&K Services Selection Board.
- (xi) The appointment/ adjustment shall be without prejudice to the outcome of any petition on the subject pending in any competent court of law.
