The engagement of the above Junior Resident shall however be subject to the following terms and conditions:

1. The appointment shall be subject to work and conduct of the Junior Resident in the college/Hospital/Dispensary remaining satisfactory during his/her tenure. In the case of misconduct or negligence in duties or found indulging in strike or any other activities which affect the hospital services/patient care, the tenure appointment of doctor shall be terminated without any notice.
2. The appointment under these rules shall not entitle the appointee to any preferential claim for regular appointment.
3. The appointee shall be whole timer and shall not engage himself/herself in private practice. In lieu of the loss of practice he/she shall be entitled to non-practicing allowance as admissible under rules. In the event of those doctors found resorting to private practice his/her appointment will be terminated without any notice and disciplinary action will be taken against him/her.
4. The Junior Resident shall be required to stay in the college/hospital premises if residential accommodation is available or he/she shall have to reside near Associated Hospital.
5. The Junior Resident shall be liable to be transferred from the college even during the period of their tenure if his/her services are required in the public interest elsewhere.
6. The Junior Resident shall be asked to give an undertaking to the effect that he/she have read the aforesaid terms and condition and he/she shall abide the same before he/she is allowed to join.
7. NOC will not be issued if any Junior Resident resigns before a period of six (06) months.
