- The appointment shall be made in accordance with the rules prescribed in the Government Order No. 132
  Dated:-19/02/2018 and amendments thereof vide Government Order No. 680 HME OF 2018 Dated:10/12/2018. The appointment under these rules shall not be entitled the appointee to any preferential claim for regular appointment.
- The academic arrangement shall cease on joining of regular appointed candidates selected and posted by the competent authority on regular basis.
- iii. The appointees on academic arrangement basis shall be paid a monthly consolidated salary as per the scales defined in the SO 364 Dated :- 27/11/2020.
- iv. The appointment against the advertised posts shall and shall always be on academic arrangement basis only without conferment of any preferential right on the engages for regular appointment against these posts which shall be made strictly in accordance with the relevant recruitment rules.
- v. The selected candidates shall have to enter an agreement that he/she will not leave the department before the completion of one year's contract. Terminating of the agreement as the case may be will require one month's prior notice on either side failing which one month's salary shall not be paid and no experience certificate shall be given.

- vi. The selected candidates may be given extension subject to good performance and conduct. The extension so granted under SO 364 Dated: 27/11/2020 shall not be beyond a period of six years under any circumstances.
- vii. The appointment under SO 364 Dated: 27/11/2020 shall not entitle the appointee to any preferential claim for regular appointment under normal process of selection/appointment.
- viii. The other terms and conditions are applicable as envisaged in the Jammu and Kashmir Medical and Dental Education (Appointment on Academic Arrangement basis) Rules, 2020 vide SO 364 Dated: 27/11/2020.
- ix. The appointee is directed to submit his/her documents in the Administrative Office and collect appointment and joining orders from the Administrative Section, GMC & AH, Rajouri.
- x. The candidate should join within 07 days from the date of issuance of this engagement order.
