Applications on the prescribed format are invited from Indian resident candidates (domicile/ non domicile) from the (in-service/ Non-PSC doctors) eligible candidates for the post of Registrar/Demonstrator on (tenure basis) in the following disciplines. However, the services of Non PSC candidates shall be hired on Academic Arrangement basis under S.O. 364 of 2020 Dated. 27-11-2020 and the PSC confirmed candidates shall be governed by the relevant rules as envisaged in the J&K Civil Service Rules 1979, initially for a period of two years extendable upto 03 years subject to good performance of the candidate during their two years of engagement, which can be obtained from the respective HOD after completion of two years of Registrarship/ Demonstratorship, as the case may be:-

Terms and Conditions:-

1. Incomplete application form(s) in any respect shall be rejected without further communications.
2. Conditions for PSC/ Non-PSC Candidates:

For In-service (PSC conformed candidates):-

- The in-service doctor shall be paid salary as per their LPC.
- The in service doctor shall be allowed to participate in the selection process only with the prior permission of the Administrative department as per circular No 05-JK (HME) of 2021 dated 21-12-2021 read with circular No 02-JK(HME) of 2020 dated 20-01-2020 and govt order no 03-HME of 2019 dated 27-05-2019. For the purpose they should route their application forms through the administrative department. No advance copy shall be entertained. No candidate shall be allowed to sit in the interview without approval.
- In case of selection, they will be allowed to join only after getting relived from their Administrative Department.

For Non-PSC candidates:

The Non PSC doctors shall be paid stipend as per S.O. 364 of 2020 Dated. 27-11-2020.

- d) Physical active field service certificate after PG/Rural service prior to PG certificate issued by the Director, Health Services, Jammu/Kashmir in respect of in-service doctors.
 - e) Attempt certificate 1st, 2nd, pre-final and Final MBBS examinations issued by the University of Jammu/Kashmir concerned.
 - f) Distinction/National Scholarship/Honors/Medals/Academic Merit certificates.
 - g) House Officer (House job experience certificate issued by the Principal concerned or equivalent recognized authority.
 - h) Diploma certificate/postgraduate degree certificate.
 - i) Date of Birth certificate
 - j) Candidates who have appeared in MD/MS/DNB examination with result likely to be declared soon can also apply. They will have to furnish pass notification from the university within 5 days of interview.
 - k) Professional publications in a standard medical Journal, if any.
4. The selected candidate has to submit an affidavit to the effect that he/she is not on the roll of any Medical Colleges/Institutions of the country which is pre-requisite In terms of NMC (MCI) norms.
 6. Maximum age for eligibility to apply shall be 50 years as on 31-07-2021.
 7. The Competent Authority reserves the right of any amendment, cancellation and changes to this advertisement as a whole or In part without assigning any reason or giving notice. The institute can withdraw any post at any point of time till the completion of selection process.
 8. The decision of the competent authority regarding selection of candidates will be final and no representation will be entertained in this regard.
 9. Separate application form is to be filled for each post and fee is to be deposited separately for each post, applied for.
 10. In case of any declaration by the candidate is found false or if the candidate has wilfully suppressed any material information relevant to his/her appointment, his/her selection will be cancelled ab-intio and he/she will be liable for action as Warranted under rules.
 11. Candidates meeting the eligibility criteria and producing all the prescribed documents will be interviewed.
 12. The selected candidates shall have to execute an agreement that he/she will not leave the Department before the completion of Registrarship/ Demonstratorship term, however abandoning/terminating of the arrangement in the Specialty will require one month prior notice on either side falling which the salary shall not be paid for one month to the incumbent which shall always remain in deposit with the Department and shall be released on completion of sanctioned term.
 13. The doctors who were earlier appointed as Registrar/Demonstrator in any discipline in GMC Rajouri or any other Medical College within the U.T of J&K but had left services before completing their tenure need not apply.
 14. NOC from Administration Department Health and Medical Education in case of in service candidate.
 15. NOC from the Head of the Institution in case of Non PSC candidates who are doing Registrarship/Demonstratorship within the U.T of J&K.
 16. PSC Candidates if selected will be permitted to join after furnishing relieving from Administrative Department.
 17. Any appointed (Doctor) intending to leave the job shall have to provide one month prior notice duly forwarded by the concerned HOD or else the doctor shall have to deposit one month salary in the institution.
- The selection of the candidates will be made on the basis of combined academic merit and performance at the Interview. No TA/DA will be admissible for appearing in interview.
