INTRODUCTION

- e-tenders are invited from reputed firms/agencies/contractors/organizations for providing of Security Services at Government Medical College, Rajouri at Mehra on outsourcing basis. The contract shall be valid for a period of One Year extendable upto one year on the satisfactory work and conduct.
- In pursuance to the above, the process of selection of agency/ firm/ organization is carried out in accordance with the Terms of Reference ("TOR") and tender to be submitted under two cover system as per the following.

A. COVER -1ST (TECHNICAL COVER) SHOULD CONTAIN:

- I. 1(i) Scanned copy of DD (amounting to the tune of Rs. 5,000/-) on account of Tender fees/Certificate.
 - 1(ii) Scanned copy of an affidavit on Rs. 50/= stamp paper duly attested by 1st Class Judicial Magistrate/1st Class Executive Magistrate/ any other authority with the effect that;
 - a. The document/catalogue etc. enclosed with the tender are original and genuine and have not been tempered with or fabricated.
 - b. The firm/agency/organization has not been blacklisted in the past by any Govt./ Private institution of the country and there is no vigilance/any other case pending against the firm /agency before any investigating agency/Court of Law.
 - c. If anything found wrong/concealed at any stage, I will be personally responsible for the consequences.
 - d. The firm/agency/organization shall abide by all the Terms and Conditions as laid down in the Tender Document.

The Financial bid of only technically qualified bidders [as specified in clause 2 (A)] shall be opened.

Terms of Reference (TOR)

1. The Department invites proposals from interested firms/agencies/organizations for providing outsourcing of Security Services in Government Medical College, Rajouri at Mehra as per the scope of work specified in the TOR. The Department intends to select the firm through an open competitive bidding in accordance with the procedure set out herein. The selected firm/agencies/contractor/organization shall be responsible for all the security related issues and all other allied works related to providing of Security Services at Government Medical College, Rajouri at Mehra. Moreover, boarding- lodging and other management of security personnel shall be managed by the firm/agency/contractor/organization at their own. It shall be the responsibility of approved firm/agency/contractor/organization to keep a close watch on the assets of the Government Medical College, Rajouri at Mehra building Complex like furniture, kitchen assets & accessories, student hostels assets, residential buildings (including Principal, HoDs & other staff) etc. The firm shall also be responsible for all allied arrangements connected for Outsourcing of Security Services in Government Medical College, Rajouri at Mehra.

2. The Proposal shall be valid for a period of not less than 120 days from the Proposal Due Date (the "PDD").

3. The Department has adopted a two-stage selection process (collectively the "Selection Process") in evaluating the Proposals comprising Technical and Financial bids. The first ranked Applicant (the "Selected Applicant") shall be called for negotiation, if necessary, while the second ranked Applicant will be kept in reserve.

4. The Department would endeavour to adhere to the following schedule:

6. A Pre- Bid Meeting may be held on the basis of request made by the interested parties.

7. ACKNOWLEDGEMENT BY APPLICANT

It shall be deemed that by submitting the Proposal, the Applicant has:

(a) made a complete and careful examination of the RFP;

(b) received all relevant information requested from the Department;

- (c) Accepted the risk of inadequacy, error or mistake in the information provided in the RFP or furnished by or on behalf of the Department or relating to any of the matters;
- (d) Satisfied itself about all matters, issues, items, things and information, necessary and required for submitting an informed Application and performance of all of its obligations thereunder;
- (e) Agreed to be bound by the undertaking provided by it under and in terms here off.

8. The Department reserves the right to reject any Proposal;

(a) if at any time, a material misrepresentation is made or discovered, or suppression of any material fact(s) is found to be made by the concerned.

(b) if the Applicant fails to provide the supplemental information sought by the Department for evaluation of the Proposal within the time as specified by the Department.

- (c) if established misrepresentation/ improper response by the Applicant may lead to the disqualification of the applicant. If such disqualification / rejection occurs after the Proposals have been opened and the lowest ranking applicant gets disqualified/rejected, then the Department reserves comprehensive right to consider the next eligible Applicant or take any other measure(s) as may be deemed fit in the sole discretion of the Department, including annulment of the Selection Process.
- (d) In case it is found during the evaluation or at any time before signing of the Agreement or after its execution and during the period of subsistence thereof, that one or more of the eligibility conditions have not been met/fulfilled by the Applicant or the Applicant has made material misrepresentation or has given any materially incorrect or false information, the Applicant shall be disqualified forthwith if not yet appointed and if the Selected Applicant has already been issued the LOA or has entered into the Agreement, as the case may be, the same shall, not with-standing anything to the contrary contained therein or in this RFP, be liable to be terminated, by a communication in writing by the Department without the Department being liable in any manner whatsoever to the Selected Applicant, as the case may be.
- 9. Applicants are advised that Selection shall be entirely at the discretion of the Department. Applicants shall be deemed to have understood and agreed that the Department shall not be required to provide any explanation or justification in respect of any aspect of the Selection Process or Selection i.e. the decision of Tendering Committee shall be final. Moreover, in case of any discrepancies and non-availability/fulfillment of condition firm/agency/contractor/organization the decision of Tendering Committee to cancel the selection process to about the tendering process including cancelation of tendering process shall be final and binding.

10. NEGOTIATIONS

The Selected Applicant may, if necessary, be invited for negotiations. The negotiations shall generally not be for decreasing/increasing the price of the Proposal, but will be for re-confirming the obligations of the applicant under this RFP. Issues such as deployment of Personnel, understanding of the RFP, methodology and quality of the work plan shall be discussed during negotiations. In case the Selected Applicant fails to reconfirm its commitment, the Department reserves the right to designate the next ranked Applicant as the Selected Applicant and invite it for negotiations.

11. COMMENCEMENT OF ASSIGNMENT

The successful bidder shall commence the assignment within 10 days of the date of the Agreement, or such other date as may be decided by the competent authority. If the applicant fails to either sign the Agreement or commence the assignment as specified herein, the Department may invite the second ranked Applicant for negotiations. In such an event, the LOA or the Agreement (as the case may be) may be cancelled / terminated and the Security Deposit in this regard shall be forfeited.

12. FORCE MAJEURE

A force Majeure means extraordinary events or circumstances beyond human control such as an event described as an "ACT OF GOD" (Like a natural calamity) or events such as a war, strike, riots crimes (but not including negligence or wrong doing predictable/seasonal rain and any other events specially excluded in the clause). Now withstanding the punitive provision contained in the contract for delay or breach of contract the supplier would not be liable for imposition of any such sanction so long as the delay or failure of the supplier in fulfilling its obligations under the contract is the result of an event covered in the FM clause.

13. NO BREACH OF AGREEMENT

The failure of a party to fulfil any of its obligations hereunder shall not be considered to be a breach of, or default under, this Agreement insofar as such inability arises from an event of Force Majeure, provided that the party affected by such an event has taken all reasonable precautions, due care and reasonable alternative measures, all with the objective of carrying out the terms and conditions of this Agreement.

14. TERMS AND CONDITIONS:

- The contractor shall carefully examine the terms and conditions. In case of any doubts, he shall (before signing the contract) refer to the officer in-charge and get requisite clarifications.
- 2. The tender should "Abide by the Labour Laws", ESI Act, EPF Act, Minimum Wages Act, PSARA (J&K) and/or various other Acts as applicable for the time being in-force with regard to the personnel engaged by the contractor for Government Medical College, Rajouri at Mehra.
- 3. The firm/agency/contractor/organization shall engage required manpower for accomplishing the job round the clock. The contractor shall strictly comply with all laws, rules, regulations as per the law in-force. Negligence on part of the approved contractor, in any shape shall lead to cancellation of contract without any notice.
- 4. All registration and statuary fees, if any in respect of the contract work pursuant to intended contract shall be responsibility of the contractor and shall be payable by the contractor only.
- Contractor shall provide Uniform, Name plates and Identity cards (full-uniform) to all the personnel engaged by him/her and will ensure that they are in full uniform during duty hours.
- 6. The same person/representative should sign all correspondence letter and documents who has signed the original tender. In case of change to this effect, and affidavit duly attested by the 1st class Judicial Magistrate shall have to be produced in support of the change.
- 7. The successful tenderer shall not in any case assign or sublet the approved contract or any part thereof to another party.
- 8. The successful bidder shall have to engage a minimum of 20% or 15 Number of the persons/security guards (whichever is higher) to be deputed at the complex/location i.e. Govt. Medical College Rajouri at Mehra from the retired military/paramilitary/CRPF/BSF (belt force) or a person having experience of services as security guard categorized as skilled (a photocopy of the service book/discharge book/experience certificate from agency where an individual has served to be uploaded by the contractor/firm/agency as a proof in this regard). The rest of the personnel may be engaged in unskilled category. The personnel so engaged shall be in sound state of physical & mental health. They shall be paid accordingly as per rules applicable to them.

9. Approximately 60 (sixty) Nos. of Security Personnel (preferably in a gender ratio of 3:1 M/F) in sound physical & mental state of health are required for Govt. Medical College Rajouri at Mehra (the number is extendable as per future requirements) as per following break-up:

- 10. The intending bidder (in his own interest) shall contact the concerned Tendering Committee, Govt. Medical College, Rajouri and visit the spot where deployment of security personnel is required before quoting the rates.
- 11. The successful bidder shall ensure the security of infrastructure and human resources (i.e. buildings/students/ employees/faculty/Machinery & Equipments etc). In case of any loss to life or valuables including infrastructure and machinery etc. due to lapse at the part of security personnel that involves theft/damage caused on belongings/infrastructure of the institution as may be established after an enquiry conducted by the competent authority the good will have to be made from the amount(s) payable to the contractor. The security personnel shall also be accountable/responsible for access to smooth movement of the material, machinery, drugs and other valuables belonging to the institution.
- 12. An indemnity bond to this effect has to be furnished by the successful bidder only i.e. the successful bidder shall have to indemnify the Equipments, buildings and other valuables kept in the administrative, academic and residential blocks of the institution (both moveable and immoveable).
- 13. Only the successful Bidder shall have to deposit an amount to the tune of 3% of the value of the contract (refundable) as Security Deposit after signing the agreement. An equal amount shall have to be deposited by the L-02 also (as a backup party in case of eventuality of non-establishment of the assignment/agreement with L-01). In case the amount as mentioned above is not deposited by the L-02 the next lowest will be considered as the L-02 and this shall be governed by the principle of cascading affect/impact (i.e. if none of the intermediate parties deposits the said amount and any party in a higher place succeeds in depositing the said amount during the course of time, the same shall be considered as L-02 and it will not be taken as any breach). The amount in this regard shall be refunded after completion of the prescribed service period. This clause shall have a final impact while deciding any dispute arising out of misinterpretation of a term relating to the securities.
- 14. The successful bidder through his security guards shall ensure that the doors and windows, are kept locked during non-working period (i.e. vacation, holidays, Sundays etc) and are properly locked after working hours (every day).
- 15. The successful bidder shall evolve a strategy for fire-fighting and will carry out mock drills in this regard (from time to time) to keep the personnel abreast with skills needed for handling any untoward situation in this regard.
- 16. The security staff shall take a round of the building of the institution daily to ensure that no unauthorized activities are allowed to take place and shall report (at source) any unusual occurrence in the institution to the concerned authorities.
- 17. The security personnel's shall have to remain alert during the period of their job and ensure that no unauthorised person is allowed in the campus. It shall be ensured that the security personnel's do not leave the duty till the shift is complete and the personnel deputed/deployed for the next shift take over. There shall be a mandatory overlap of at least 20 minutes during exchange of duties between two parties.
- 18. The successful bidder shall have to ensure that no suspicious object is lying in the complex for which he shall be solely responsible for the consequent un-toward incident. In such a case the concerned authorities have to be informed with immediate effect.
- 19. The successful bidder shall provide proper uniform to the security personnel's with name plates/badges for proper identification of the workers. Moreover, the security personnel's shall be equipped with necessary aids, such as torches, lathies, metal detectors etc., during the working hour. All these items shall be provided by the bidder. The department shall only provide control room for placement of equipments of the security staff.
- 20. The Medical College authorities shall have the right to dispense with the services of any security staff, if not found up to the mark or any misconduct/ misbehaviour is reported on the part of the concerned.

- 21. The personnel engaged/deployed for security by the successful bidders at Govt. Medical College Rajouri at Mehra shall work under the over-all supervision of a senior (as designated by the concerned). The duty roster (monthly) shall be provided by the successful bidder to the GMC Administration by or before last date of every month.
- 22. The successful bidder shall enter into an agreement with the concerned authorities of the Govt. Medical College Rajouri at Mehra before the allotment of the contract.
- 23. Any dispute arising out of this contract shall be referred to the Administrative Department, Health and Medical Education and the outcome of the decision shall be final and binding upon all the parties in letter and spirit.
- 24. Any legal proceedings in this regard shall be subject to the Jurisdiction of District court at Rajouri/ Hon'ble High Court of J&K at Jammu only.
- 25. All liabilities arising out of the accident or death (while on work) of the personnel engaged by the contractor shall be solely borne by the contractors for all purposes.
- 26. The contractor shall have to maintain an attendance system in which day to day deployment of personnel will be entered. The register shall remain available for inspection by the authorised representative of Govt. Medical College, Rajouri or a person from administration not less than the rank of Administrative Officer or the person who heads a section of the administration from time to time. In this regard all the security personnel shall be required to get themselves registered on Biometric/Facial Attendances System of the Govt. Medical College for comprehensive monitoring for the convenience of the concerned authorities on account of the ensured attendance.
- 27. The personnel engaged thereof must be in a good state of heath and must be of robust physique ensuring utmost discipline while discharging their assignment/duties. If established otherwise the Administration shall have a comprehensive right to have any person got removed and ask for a suitable replacement from the concerned agency.
- 28. The personnel(s) so engaged should have a clean track record in terms of National Security and Social Wellness of the society. They shall not have got involved in any anti-national/anti-social activity in past. The institution shall not be responsible to bear with any proceedings (as an outcome of the legal discourse) against the concerned and only the contractor shall be responsible and answerable to the concerned investigating agencies in this regard. Any such instance may invite the action as warranted under rules/cancellation of the contract/removal of the person (under investigation) with immediate effect. No notice in this regard shall be served to the concerned in case of cancellation of contract. Under such circumstances the contract shall be passed to the next eligible firm for the remaining period of time on same terms & conditions as laid down in the agreement executed by the previous agency or as it seems fit to the authorities thereof.
- 29. The security personnel so engaged shall have to work in three shifts stretching on period eight hour each i.e. morning, wait and night. These shifts shall normally be divided as Morning shift- 06:00 hrs to 14:00 hrs, Wait shift- 14:00 hrs to 22:00 hrs & Night shift- 22:00 hrs to 06:00 hrs or as decided by preparty. Prolonged duty hours (more than eight (08) hours at a stretch) shall not be allowed under any circumstances and if established the authorities shall have a right to the action as warranted under rules including termination of the contract without any notice.
- 30. The security personnel deployed by the contractor shall work under overall supervision and direction of the Administration. The Administration shall specify the services of guards to be obtained in each shift.
- 31. The contract shall be terminated within 15 days if not found workable. A notice of termination in this regard will suffice the process initiation of reallotment of the assignment to the next/any other party.
- 32. The payment would be made on monthly basis (depending upon the availability of funds) for actual shifts mannered/operated by the personnel supplied by the contractors and based on the attendance sheet duly verified by the concerned authorities. The contractor will ensure the worker(s) engaged by him/her must receive their entitled wages on time. In view of this, the following procedure shall have to be adopted.
 - a) Contractor shall pay the entitled wages to his workers on the last day of the month.
 - b) Payment to such workers must be made by the service providers through online/invoice transfer directly to the account holder (person engaged by the organization/agency/contractor).
 - c) In order to ensure that such workers get their entitled wages on the last working day of the month, the following schedule will be adhered to:

- Monthly bill cycle shall be from 24th day of the previous month to 23th day of current month.
- ii) Monthly bill as per above cycle shall be submitted by the service provider on 26th of the current month.
- d) The service provider shall ensure that entitled wages of the workers are credited to their bank account on the last working day of the month without any fail. Any relaxation in this regard shall not be mandidated to the Service provider.
- e) While submitting the bills for the next month, the service provider will submit a certificate detailing the facts as under;
 - i) Wages of workers were credited to their bank accounts on (date).
 - ii) ESI contribution related to workers amounting to Rs. _____was deposited on (date) (copy of the challan enclosed).
 - iii) EPF contribution related to workers amounting to Rs. _____was deposited on per month (date) (copy of the challan enclosed).
 - iv) He is complying with all statutory Labour Laws including minimum wages Act. Moreover, the list of such account holders along with the name and address of the security personnel be furnished in the account section of this GMC periodically for reference and record. The other banking details like IFSC code of the bank and other relevant information linked to the security persons deputed may also be furnished to the account section of this GMC.
- f) The service provider should submit the bill in accordance with the above tender schedule. In case he fails to submit the bills, by 26th of month, even then he has to make the payment to the workers on the last working day of the month.
- 35) a) In case, any personnel deployed under the contract fails to report in time and contractor is unable to provide suitable substitute in time for the same. It will be treated as absence and penalty of Rs. 500/- per vacant point per shift be deducted from the contractor bill.
 - b) In case any public complaint is received attributable to misconduct/misbehaviour of security personnel, and is accessed as true by Administration, a penalty of Rs. 1500/- for each such incident be levied and the same shall be deducted from contractor bill. Besides, the Security Guard found involved in the incident shall be removed from the duty immediately.
 - c) In case the contractor fails to commence/execute the work as stipulated in the agreement and gives unsatisfactory performance or does not meet the requirements of the contract, Principal, Govt. Medical College, Rajouri reserves the right to impose the penalty as deemed fit. The Principal, Govt Medical College, Rajouri reserves the right to cancel the contract without any notice.
- 36) In the event of any breach/violation of any terms and conditions contained herein by contractor, the security deposit of the agency shall stand forfeited.
- 37) Any liability arising out of any litigation including those in consumer court due to any act of the security personnel shall be directly borne by the contractor including all expenses/ fines. The concerned security personnel shall attend the court as and when required.
- 38) During the course of contract, if any Security personnel is found to be indulging in any corrupt practice or causing any loss of property of Govt. Medical College Rajouri the authorities shall be entitled to terminate the contract forthwith including forfeiting the performance Guarantee.
