**Subject:-** Representation filed by Dr. Farida Khanam D/O Mohd Aslam, R/O Village Pulian, PO-Dassal Jatan, Tehsil & District Rajouri requesting to allow her to participate in the interview process without receiving her Application Form through proper channel for the post of Demonstrator/Registrar in the discipline of Anatomy advertised vide notice no. 908/GMCR of 2022 dated 18-03-2022.

ORDER NO. 18 GMCR OF 2022

Whereas applications have been invited from the eligible candidates (In-Service/Non-PSC) for the post of Registrar/Demonstrator on tenure basis in various disciplines including the discipline of Anatomy vide advertisement notice no 908-GMCR of 2022 dated 18-03-2022.

And whereas In-Service candidates have to seek prior permission of the Administrative department as per circular No 05-JK (HME) of 2021 dated 21-12-2021 read with circular No 02-JK(HME) of 2020 dated 20-01-2020 and order no 03-HME of 2019 dated 27-05-2019 in terms of said notice. For the propose also, they have to route their application forms through the administrative department.

And whereas the applicant above named has applied for the post in the discipline of Anatomy under In-Service Category without obtaining prior permission from the administrative department and her application form has also not been routed through proper channel.

And whereas she has also filed a representation dated 07.04.2022 requesting to allow her to participate in the interview process without receiving her application form through proper channel as she is claiming that she has availed prior permission from the administrative department and her



application form has been routed by Chief Medical Officer, Samba to Director Health Services Jammu and same is pending before Director Health Services, Jammu.

And Whereas Learned Deputy Advocate General, Sh. Sudesh Mangotra Hon'ble CAT has intimated telephonically that the applicant has approached Hon'ble CAT, Jammu Bench by way of Original Application and that the Hon'ble Tribunal has been pleased to pass an order directing GMC Rajouri to decide the pending representation of the applicant today in consultation with Respondent No 2 & 3 i.e Director Health Services, Jammu and Chief Medical Officer, Samba.

And whereas, copy of said order passed in the OA has not been received and it may take much time to make formal correspondences with Director Health Services, Jammu and CMO Samba.

Thus in the circumstances, the applicant is allowed to participate in the interview process which is scheduled to be held on 13-04-2022. However, final selections shall be decided on merits and after taking into consideration order passed in the Original Application and after receipt of formal correspondences from Director Health Services Jammu.
