The engagement of the above Demonstrator/ Registrar shall, however, be subject to the following terms and conditions:-

- 1. Tenure appointment shall be subject to work and conduct of the Demonstrator /Registrar in the college / Hospital / Dispensary remaining satisfactory during his/her tenure. In the case of misconduct or negligence in duties or found indulging in strike or any other activities which affect the hospital service / patient care, the tenure appointment of Doctor shall be terminated without any notice. In the event of any vacancy ceasing to exist in any discipline the last Doctor/candidate appointed in the discipline will be reverted to his / her parent service.
- 2. The Doctor/candidate shall be whole timer and shall not engage himself / herself in private practice. In lieu of the loss of practice he / she shall be entitled to non-practicing allowance as admissible under Rules. In the event of those doctors found resorting to private practice their tenure appointment will be terminated without any notice and disciplinary action will be taken against them.
- 3. The Doctor/ candidate shall be required to stay in the College / Hospital premises if residential accommodation is available.
- 4. The Doctor/ candidate shall be liable to be transferred from the College even during the period of tenure ship of Demonstrator/ Registrar if his / her services are required in the public interest elsewhere.
- 5. No Registrar/Demonstrator appointed under this order shall be allowed to apply for any job during the tenure of Registrar ship/Demonstrator ship nor the controlling authority shall forwarded any such application to the concerned quarters and any application forwarded by their parent department before taking up job of the Registrar ship/Demonstrator ship shall be treated as cancelled.
- 6. The Registrar/Demonstrator shall be asked to given an undertaking to the effect that he /she have read the aforesaid terms and conditions and she shall abide the same before he / she is allowed to join.

7. The appointees shall submit his/her joining report to the undersigned only after a formal letter sent to the department concerned after ensuring that all the requisite formalities

8. They shall have to reside in or near college campus.

9. Any appointee (Doctor/ Candidate) intending to leave the job shall have to provide prior one month notice duly forwarded by the concerned HOD or else the doctor shall have to deposit one month's salary in this institution.

10. Further the in-service doctor/ candidate shall have to produce service book and LPC from

their parent department.

11. No experience certificate will be issued before one year tenure.

12. This order is without any prejudice and shall remain always subject to the outcome of any writ petitions lying/pending before any Hon'ble court of law.
