Medical College Rajouri on Academic Arrangement basis under SO 364 dated 27.11.2020 in case of Non-PSC candidates initially for a period of one (01) year extendable up to 03 years subject to satisfactory performance of the candidates during their 1st and 2nd years of engagement, which can be obtained from the respective HODs after completion of 1st and 2nd year of Registrarship/ Demonstratorship as the case may be and for In-service doctors according to their terms of deputation.

 For In-service (PSC conformed candidates: The in-service doctor shall be paid salary as per their LPC. The in-service doctor shall be allowed to apply only with the prior permission of the administrative department as per circular No 05-JK (HME) of 2021 dated 21-12-2021 read with circular No 02-JK (HME) of 2020 dated 20-01-2020 and Government order no 03-HME of 2019 dated 27-05-2019. For the purpose they should route their application forms through the administrative department only. In case of selection, they will be allowed to join only after getting relived from their Administrative Department.

- The Non-PSC candidates shall be paid salary as per S.0. 364 of 2020
 Dated. 27-11-2020.
- The selection of the candidates will be made on the basis of combined academic merit
 as per the relevant rules/orders by the selection committee constituted for the
 purpose as per Govt. Order No. 282 JK(HME) of 2023 dated 04.04.2023.
- The candidate who have left the Senior Residency mid-way need not to apply.
- The candidates will be required to produce relevant certificates as mentioned above
 in original also as proof of having acquired the prescribed educational qualification on
 or before the last date of the submission of application form, failing which the
 candidature of such candidates shall be cancelled by the selection committee.
- Candidates may note that their candidature will remain provisional till the genuineness of their documents relating to educational qualification is verified by the Appointing Authority.
- The candidates are advised to go through the requirements of educational qualification and certificates to satisfy themselves that they are eligible for the post. If the documents submitted by the candidates are not found substantiated or correct by the committee at any point of time, the candidature will be cancelled and appropriate proceedings under law shall be taken.
