- (ii) In case any appointee does not join within a period of 21 (Twenty one) days from the date of issuance of the appointment order shall forego their right to appointment which shall be deemed to have been cancelled abinitio without any further notice.
- (iii) Each appointee shall give an undertaking in the shape of an affidavit to the effect that in case adverse report about his/her character and antecedents is received from the Inspector General of Police (CID), J&K, to whom a reference shall be made by the Principal, GMC Rajouri, the candidates shall have no right to claim his/her appointment and his/her appointment as such, shall be deemed to have been cancelled ab-initio.
