The engagement of the above Junior Resident shall however be subject to the following terms and conditions:

1. The appointment shall be subject to work and conduct of the Junior Resident in the college/Hospital/Dispensary remaining satisfactory during his/her tenure. In the case of misconduct or negligence in duties or found indulging in strike or any other activities which affect the hospital services/patient care, the tenure appointment of doctor shall be terminated without any notice.
2. The appointment under these rules shall not entitle the appointee to any preferential claim for regular appointment.
3. The appointee shall be whole timer and shall not engage himself/herself in private practice during his/her engagement as such. In lieu of the loss of practice he/she shall be entitled to



non-practicing allowance as admissible under rules. In the event of those doctors found resorting to private practice his/her appointment will be terminated without any notice and disciplinary action will be taken against him/her.

4. The Junior Resident shall be required to stay in the college/hospital premises if residential accommodation is available otherwise he/she shall have to reside near Associated Hospital.
5. The Junior Resident shall be liable to be transferred from the college even during the period of their tenure if his/her services are required in the public interest elsewhere.
6. The Junior Resident shall be asked to give an undertaking to the effect that he/she have read the aforesaid terms and condition and he/she shall abide the same before he/she is allowed to join.
7. NOC will not be issued if any Junior Resident resigns before a period of 06 months.
8. Any appointee doctor intending to leave the job (after 06 months) shall have to provide one month's prior notice duly forwarded by the concerned HOD or else he/she will have to deposit one month's salary with the institution.
9. The above candidates shall report to the Principal, Govt. Medical College Rajouri within seven days of issuance of this order failure of which the appointee shall forego his/her appointment and his / her appointment has been cancelled ab-initio without any further notice.
10. The appointee under these rules shall have to execute an agreement with the Government on the prescribed form appended as form "A" to these rules.
11. In case of any interpretation and relaxation regarding the above terms and conditions is concerned, the decision of the undersigned shall be final.
12. This order is issued without any prejudice to any writ petitions lying pending before any Hon'ble Court of Law.
