- In case any appointee does not join within a period of 21 (Twenty one) days from the date of issuance of the appointment order shall forego their right to appointment which shall be deemed to have been cancelled ab-initio without serving any further notice.
- Verification / genuineness of the qualification certificates and the reserved category certificates from the concerned issuing authorities.
- The salary of the appointees shall not be drawn and disbursed to them unless the satisfactory report in respect of (iii) above is received in their favor.
- The appointment of these candidates shall be governed by under Jammu and Kashmir Probationer (Condition or service, Pay and Allowances) and Fixation of tenure Rules, 2020, notified vide S.O 192 dated 17-06-2020 & S.O 193 dated 17-06-2020.
