The appointment of the candidate shall be subject to the following conditions:

- The appointee shall report to the Principal, Government Medical College, Rajouri within 21 days from the date of issue of this order along with all the original certificates, two photo copies of all educational and other concerned certificates i.e. Domicile Certificate/Permanent Resident Certificate, Category Certificate (if any), No Objection/Loan Certificate from District Industrial Centre and District Employment Exchange, Character Certificate issued by the concerned Police Station and Medical Fitness Certificate signed by Chief Medical Officer.
- In case the appointee does not join within a period of 21 (Twenty one) days from the date of issuance of the appointment order he/she shall forego his/her right to appointment which shall be deemed to have been cancelled ab-initio without serving any further notice.
- Verification/genuineness of the qualification certificates and the reserved category certificate (if any) from the concerned issuing authorities.
- The salary of the appointee shall not be drawn and disbursed to him/her unless the satisfactory report in respect of condition (iii) is/are received in his/her favour.
- The appointee shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24-12-2009.
- The interim arrangement, of any made against the above post shall be deemed to have been terminated forth-with.
- The appointee in Divisional Cadre is non-transferable from one Division to another or from one Government Medical College to another.
- The inter-seniority of the above appointee shall be as per the merit secured by him/her in the selection process as indicated against his/her name in the selection list furnished by the J&K Services Selection Board.
- The appointment of the selected candidate shall further be subject to outcome of writ petition(s) if any pending on the subject in any court of competent jurisdiction.




